The Civilian Review and Complaints Commission (the Commission) is writing to acknowledge receipt of additional information regarding your public complaint. If you are not satisfied with the RCMP's handling of this public complaint file you may make a request for review upon receiving the final report. Please be advised that the public complaint process does not result in punitive measures and, as such, will not result in the resignation of any RCMP member or CRCC staff and, furthermore, the Commission cannot lay criminal charges as we are not a law enforcement agency.

The following information has been forwarded to the RCMP on your behalf:

**THE FOLLOWING WAS RECEIVED BY THE COMMISSION VIA ONLINE COMPLAINT FORM:**

I will accept absolutely nothing less than the immediate resignation and formal Reprimand of Michelle. She will be terminated with Cause on her HR file.

I will accept absolutely nothing less than the immediate resignation and formal Reprimand of Corporal. He will be terminated with Cause on his HR file. I'm also asking for charges of Fraud.

2 Members of the Civilian Review Board of Directors will resign.  
Children, disabled woman, cancer patients were threatened. I've submitted an image of RCMP vest, was stalked out of my sister's driveway by RMCP because I'm Gay, I was stalked up and down the road by RCMP as I was protesting racism and there was a newspaper article on it. The officer involved were asked 20+ times to allow me to open a case and they refused stating basically I'm just retarded so i don't get rights. The abuse was so bad, another officer had to stop Jessica and put his hand on her shoulder and say "You need to stop, this is way above our paygrade", I have the recorded call when reporting abuse and stating these people told me if i even mention JDIrving they will just have me arrested and pumped full of drugs while you can hear someone say good in the background while they then called mental health service sot LITERALLY TERROIZE ME AND MY FAMILY.

These cops showed up threatening me and terrorizing me as I had blisters on my feet

walking to see / hand feed my mother in the hospital. This is the short list....
