As such, the following information has been forwarded to the RCMP on your behalf:

THE FOLLOWING WAS RECEIVED BY THE COMMISSION VIA ONLINE COMPLAINT FORM:

I am calling for the immediate resignation of the Executive member of the Board Of Directors. The only way these people would think this behavior is acceptable, is if they know how corrupt their Board of Directors are.
